So they place a sell order first, and then close the position with a buy order after making a profit. Forex or forex exchange is a market where currencies can be exchanged for each other. Whether exchanging Euros with dollars or dollars with rupees, all this is a part of Forex i.e. foreign exchange market.

# What is cryptocurrency trading...?

Cryptocurrency trading means buying and holding a digital currency and making a profit by selling it when its value increases.

Cryptocurrency is a virtual currency, which is not under the control of any central bank.

It is not regulated by any government institution and its value depends on demand.

Cryptocurrencies are stored and deposited in crypto wallets. These wallets are either hot or cold. Hot wallets are connected to the internet, and are not cold. For cryptocurrency trading, you have to use an exchange. To use a crypto exchange platform, you have to pay commission etc. On selling, the coins will come out of your wallet and go to the account of the person buying. At the same time, the opposite will happen if you buy.

Investing in cryptocurrencies, like the stock market, is high risk. Buying and selling rates fluctuate regularly.

This means that someone can invest a large amount of money in crypto and end up losing all or most of it.


